Life Team Agreement

TO PARTICIPATE IN LIFE 2019 TRIP, This agreement must be signed and returned by the participant and also must be signed by a parent or legal guardian. Failure to accept and/or abide by the terms and conditions of this Agreement as provided may result in the Participant's inability to participate in the LIFE Trip.

I, (PRINT NAME) _____, have agreed to be a Participant with the Auburn Alliance Youth Group to attend LIFE 2019. In consideration of being allowed to participate in this trip, I hereby state and agree as follows:

1. Standards of Conduct

I agree to abide by Auburn Alliance's conduct RULES AND GUIDELINES as outlined in this agreement, as well as the directions of the Leaders, agents and representatives. I understand that the Team leader(s) has the right to enforce appropriate standards of behavior and that I may be dismissed from the trip at any time for failure to comply with such standards. Auburn Alliance and its leaders reserves the right to remove me from the trip and/or send me home early at any time should my actions or general behavior impede the trip, or the rights and welfare of any person, including but not limited to my own welfare. I understand that if my participation in the trip is terminated, I will be sent home with no refund of fees. If I am sent home before completion of the trip, I understand that I will be responsible for any and all costs and expenses associated with my return home.

- I will conduct myself in a mature, respectful and appropriate manner.
- No alcoholic beverages, illegal drugs, or tobacco products, fireworks, weapons of any kind.
- No going outside the hotel or convention center alone or unsupervised by a designated Team Leader.
- No in appropriate romantic displays of affection of any kind, at any time, with any person (unless married).
- No departing from your LIFE team and assigned group. You are never to be alone.
- No fighting, noisy or disorderly conduct, profanity or temperamental outbursts.

- No two individuals of the opposite sex alone out of sight of the group (unless married).
- No entering rooms of the opposite sex.
- I will attend and engage as much as possible leading up to the trip, at youth group, team meetings, fundraising events, etc.

2. Institutional Arrangements

I understand that Auburn Alliance Church (AAC) does not represent or act as an agent for, and cannot control the acts of omissions of, any host institution, host family, transportation carrier, hotel, trip organizer, or other provider of goods or services involved in the Life trip. I understand that AAC is not responsible for matters that are beyond its control. I hereby release Auburn Alliance Church and leaders from any injury, loss, damage, accident, delay, or expense arising out of any such matters.

3. Program Changes

I understand that Auburn Alliance Church reserves the right to make cancellations, substitutions, or changes to the trip in its sole discretion, with or without notice, and that AAC shall not be liable for any loss to the Participants by reason of any such cancellation or change.

4. Health and Safety

A. I release and absolve Auburn Alliance Church (AAC) of all responsibility and liability for any injuries, illnesses (including death), claims, damages, charges, bills and/or expenses I may incur, including periods before, during, and after the duration of the trip.

B. I understand that I am responsible for ensuring that I am adequately covered by health and accident insurance including periods before, during, and after the duration of the trip. Any information I want Auburn Alliance Church (AAC) to have

for me regarding coverage for accident, illness, hospitalization, accidental death and dismemberment, and emergency medical evacuation will be provided separate from this agreement.

C. I agree to report to Auburn Alliance leaders as soon as I become aware of such, any physical or mental condition I have which may require special medical attention or accommodation while traveling.

D. I am aware of all applicable personal medical needs. I have arranged, through insurance or otherwise, to meet any and all needs for payment of medical costs while I participate in the trip. I recognize that Auburn Alliance Church (AAC) is not obligated to attend to any of my medical or medication needs, and I assume all risk and responsibility thereof. If I require medical treatment or hospital care, before, after, or during the mission trip, Auburn Alliance Church (AAC) is not responsible for the cost or quality of such treatment or care.

5. Medical Treatment Authorization

I, (PARTICIPANT), authorize the AAC, through its agents and representatives, to take whatever action is deemed necessary with respect to my health and safety. I authorize AAC and its agents and representatives to place me, at their discretion and without my further consent, in a hospital or in the care of a local doctor for medical services and treatment. If necessary or desirable, I also authorize them to transport me back home for medical treatment. I agree that I, along with my parents or guardian if applicable, will be fully responsible for any and all expenses, including transportation costs, associated with or in any way related to my medical care. Note: To the best ability of the leader given the situation, will give effort to contacting parents or legal guardian before proceeding.

I also understand that failure to meet any one of the application processes and/or deadlines in regards to participating in training sessions and my financial responsibilities may result in Auburn Alliance Church (AAC) cancellation of my trip without refund. Should I choose to withdraw from the trip, I am responsible for any expenses Auburn Alliance Church (AAC) has incurred on my behalf. As long as I have cancelled with enough time to find a replacement. If I have cancelled I will forfeit the \$100 deposit and any and all money pay for me or on my behalf.

6. Financial Responsibility

I acknowledge that I have entered into a financial agreement with AAC in order to participate in the Life 2019 trip and I am responsible for paying the full amount of the trip cost should fundraising efforts fall short. I understand that all fundraising projects, dates, and costs surrounding the trip are best estimates and are subject to change.

7. Assumption of Risk and Release of Claims

A. I hereby acknowledge my awareness that my participation in the trip may expose me to risk of property damage and bodily or personal injury, including death. I understand that the risks I may encounter include by way of example: airplane crashes, motor vehicle accidents, terrorist incidents, cuts, bruises, broken bones, sickness, political unrest, strikes, acts of God, and criminal acts as well as other risks that may or may not be foreseeable. I HEREBY ASSUME ANY AND ALL SUCH RISKS, AND I ACKNOWLEDGE THAT I AM RESPONSIBLE TO ACT REASONABLY AND PRUDENTLY WITH RESPECT TO MATTERS OF PERSONAL HEALTH AND SAFETY.

I understand and acknowledge that Auburn Alliance Church (AAC) assumes no responsibility or liability, in whole or in part, for any delays, delayed or changed departure or arrival times, fare changes, dishonors of hotel, airline or vehicle rental reservations, missed carrier connections, sickness, disease, injuries (including death), losses, damages, weather, strikes, acts of God, circumstances beyond the control of Auburn Alliance Church (AAC), war, quarantine, civil unrest, public health risks, criminal activity, terrorism, expense, inconveniences, cessation of operations, mechanical defects, failure or negligence of any nature howsoever caused in connection with any accommodation, restaurant, transportation, or other services or any substitution of hotels or of common carrier or other circumstances

beyond Auburn Alliance Church's (AAC's) control, with or without notice, or for any additional expenses occasioned by any of the foregoing. If due to weather, flight schedules or other uncontrollable factors I am required to spend additional nights, Auburn Alliance Church (AAC) will not be responsible for my hotel transfers, meal costs, or other expenses. My baggage and personal property is at my risk entirely. The right is reserved by Auburn Alliance Church in its sole discretion, to cancel the LIFE trip or any aspect thereof after departure, requiring that all participants return home, if Auburn Alliance Church determines or believes that any person is or will be in danger if the mission trip or any aspect thereof is continued.

KNOWING THE RISKS DESCRIBED ABOVE, and in consideration of Auburn Alliance Church arranging for my participation in the trip, individually and on behalf of any family, heirs, assigns, and personal representative(s), to the maximum extent permitted by law, I HEREBY ASSUME THESE RISKS AND RELEASE, WAIVE, AND FOREVER DISCHARGE Auburn Alliance Church, its board of directors and their officers, agents, and employees (the "Releasees") from liability for any and all harm, injury, claims, demands, rights, causes of action, costs and expenses of whatever kind, arising from or by reason of any loss, damage, or injury sustained by me or caused to my property, or the consequences hereof resulting from or in any way connected with my participation in the mission trip.

B. The terms of this agreement shall be severable, such that if a court holds any term to be illegal, unenforceable, or in conflict with any law governing this agreement; the validity of the remaining portions shall not be affected thereby.
